

- Organize
- Dialogue
- Action
- Evaluation/Follow-up

Cook County's Engagement Activities

- Emerging adult forums
- Intergenerational forums
- Community dialogues: A series of 5-week sessions with the same community participants
- Onsite presentations to community and faith based institutions.





Challenges

- Vulnerability of internal stakeholders to engage community
- Community lack of trust with government
- Relationship building with groups/individuals who have been negatively impacted by justice system
- Traditional outreach ineffective



Lessons Learned

- Address stakeholders concerns
- Build community trust
- Trust the voices of community



Outcomes to date

- Over 60 organizations & individuals represented on CEC
- 100% of county public safety stakeholders represented on CEC
- Over 100 community members engaged in initial kick-off community summits





WORLD CAFÉ MODEL

Raising awareness and educating community on diversion and deflection strategies



Overview- World Cafe

A structured conversational process for knowledge sharing in which groups of people discuss a topic at several tables, with individuals switching tables periodically and getting introduced to the previous discussion at their new table by a "table host".

World Café A Participatory Process

- Participatory Processes (PP) are specific methods employed to achieve active participation by all members of a group in a decision making process.
- This approach can be used for most issues and should give equal opportunities for everybody involved.
- The primary goal is to create productive discussions to develop positive solutions.



Challenges

- Skill set acquisition and practice
- Follow up
- Continuity in interest

Lessons Learned

- Reaffirming the necessity for processes such as this one
- Collective impact is vital to sustainable change
- The importance of community capacity building
